- VDOT contacted for speeding and traffic concerns, increased police presence requested.
 - Limited number of officers on duty for our county
- RSG contact has ended, and James River is handling landscaping and lawn care.
 - o Snow removal and social center gutter cleaning is included with the contract.
- Going green! No more coupon books.
- Lighting around Hutter Lake is being updated, quotes for solar-powered lighting.
- Walking trails and signage around Lake Vista will be updated.
- Annual yard sale weekend first weekend of June from 8:00 AM noon
- Playground to replace volleyball court to be considered by the board.
- Fish restocking for Spring 2025; bass are predator fish and their numbers will be decreased by electrofishing and removal to help rebalance the populations. Fish fry habitat will be increased, native plants introduced, and water quality measures implemented this year.

- Fall cleanup day was a success!

- Spring cleanup day is re-scheduled for 4/29/23 (rain date)
- Solitude Lake Management to provide comprehensive protocol for algae, water analysis, plant life, and oxygen levels – long-term planning for lake beautification.
- Drainage research for swampy areas is being gathered (i.e. 603 Lake Vista)
 - o Boardwalk and floating docks are being considered for future projects.
- New sign and handrail for the meadow area no plans for adding parking there.

- Trees added to increase drainage in areas around Hutter Lake and Lake Vista, removal and replanting by Monster Trees
- Removed old rusty grill and barrel, cleaned and painted Picnic Point
- Gate replacement completed at Bayberry Cove dam entrance.
