About the LVPOA Community Canoe

LVPOA maintains a 15 foot canoe (LVPOA Registration No. 158) for use by property owners and guests for their boating pleasure on Lake Vista. This canoe is made by the Coleman Company, Inc. is green plastic and is kept at Spinnaker Point in rack No.5, Section C. Located next to Rack No.6 is a locked plastic chest which contains two adult life vests, one child's and one infant's life vest, plus 2 canoe paddles. The National Marine Manufacturers association have rated the safe loading of the canoe as three (3) persons, totaling 740 lbs. Residents can reserve use of the canoe, paddles and life vests by calling the LVPOA office at 385-7594, Mon.-Fri. 9:00 AM to 5:00 PM.

Please note that you must be 18 years old (or 16 to 17 with a parent's signed permission). A Waver of Liability statement must be signed and by said signing you will assure that the canoe will be operated in a safe and responsible manner and you will utilize the life jackets provided. On board adults will also need to sign a Waiver of Liability.

Policy on the Use of the LVPOA Community Canoe

- The LVPOA canoe is for use of Lake Vista residents and their guests only. Residents
 must be with their guests in the canoe.
- 2. The canoe is available for use, without charge, and must be used on Lake Vista only.
- 3. The canoe must be reserved in advance. (First come first served) It may be reserved for a maximum of six hours use. This may be extended to 12 hours if no one else has requested to use it on the same day.
- 4. You must be 18 years old or older or 16 or 17 with a parent's co-signature on the Reservation.
- 5. All users including guests must sign the LVPOA Boat Usage Waiver of Liability form.
- 6. All canoe riders are required to wear life vests while in the canoe.
- 7 Loading of the canoe must be within the maximum of 3 persons and not exceed 740 lbs total weight.
- 8. Animals, alcoholic beverages, weapons, fireworks, or illegal substances are **not** allowed to be taken or carried in the canoe.
- 9. Users will be held responsible for cleaning out any trash generated while using the canoe and returning it, the paddles and life vests to their proper storage areas.
- 10. Deliberately up-setting the canoe or filling it with water is not permitted.
- 11. Violation of these rules may result in denying the canoe's future use.

Lake Vista Property Owners Association Community Canoe - Waiver of Liability Statement

In consideration of the granting of my request to be allowed to borrow the LVPOA canoe, I hereby state that:

- I hereby recognize that there are dangers and risk of injuries and loss inherent in operating any boat and I understand that the use of the LVPOA's canoe could be harmful or dangerous both to myself and to anyone else on board or in other watercraft. With full knowledge of such risk I desire to borrow the canoe.
- I represent and warrant to LVPOA that I am able to operate the canoe and have read and understand its safe loading capacities and that all aboard are to wear life vests when on the water.
- 3. I fully accept the personal responsibility and accountability for my use of the LVPOA canoe.
- 4. I hereby waive for myself, my guests, my heirs and assigns, any and all demands, obligations, liability suits, actions and causes of action and claims of every nature whatsoever which I may have against the LVPOA, its officers and members, including those who manage the canoe sign-out process, caused by or resulting from my use of the canoe. This Waiver of Liability shall remain in effect as long as I remain a member of LVPOA, or participate in LVPOA activities as a non-member or visitor.
- 5. I hereby agree indemnify and hold harmless the LVPOA, its officers and members from any losses, liabilities, damages or costs which the LVPOA may incur, directly or indirectly, due to my use or operation of the canoe, including but not limited to losses or injuries suffered by persons not a party to this agreement.

I hereby acknowledge that I have read, understood and voluntarily signed this Waiver of Liability statement and expressly agree that this waiver is intended to be as broad and inclusive as permitted by the laws of the Commonwealth of Virginia.
